Local Coronavirus figures

The current local Coronavirus figures can be found on the Government website:

These figures are for the week ending 13/03/21, and comparisons are with the week ending 06/03/21:

- The case rate per 100,000 for all ages is: Norfolk 38.7 (34 previous week), East of England 44.3 (48.7 previous week) and England 58.3 (60.4 previous week). Overall, this represents an increase in Norfolk of 13.6%.
- In King's Lynn and West Norfolk, the case rate per 100,000 of all ages is 66.1 compared to 51.5 the previous week – an increase of 28.2%.
- This compares to figures for the rest of Norfolk this week: Breckland 64.3; Broadland 33.6; Great Yarmouth 33.2; North Norfolk 15.3; Norwich 30.6; and South Norfolk 34.8.
- The total number of people tested for Covid-19 in the last 7 days is 28803, compared to 24711 for the previous 7 days (23.6% increase).

The figures show an increase in west Norfolk. It is vital, now more than ever, that we continue to be vigilant and communicate the stay at home messaging.

We are expecting national communications material next week to share with residents as we come out of lockdown. This is expected to be around hands, face, space and fresh air. There will also be messages encouraging residents to enjoy Easter safely, around barbecues and camping.

83.3% of people aged 55 and over in our borough have received their first dose of vaccine against COVID-19. 49.4% of all adults (people aged 16%) have been vaccinated in west Norfolk. I'm sure that the opening of the large scale Downham Market vaccination centre will help increase the figures. Initially they forecast to deliver 1,000 vaccinations a week there. I've attached a more detailed breakdown of the vaccination progress in our borough to this email. You may be concerned about national news stories related to supply issues for the vaccine, we are waiting to hear more details about this from the NHS and CCG. Whilst the take up has been very good, we are now in a position where a number of vaccination sites across Norfolk and Waveney will temporarily offer a 'drop-in' vaccination clinic where no appointment is needed.

Patients over the age of 55 who have not already booked or received their first dose can attend the following vaccination sites on dedicated days and times; just turn up with a valid form of ID to confirm your age and where possible, your NHS number:

- The Inspire Centre at The Queen Elizabeth Hospital NHS Foundation Trust (QEH), King's Lynn, PE30 4ET, 8:30am to 7:30pm, Tuesday 23 March and Friday 26 March 2021

This drop-in pilot comes as a result of diversifying the way in which vaccinations are provided across Norfolk and Waveney, encouraging people from younger age groups and harder to reach communities to access vaccinations in ways which are more convenient and accessible to them.

Whilst we know vaccination appointments have been offered to everyone over the age of 50, these drop-in clinics is a targeted pilot to encourage those who haven't yet booked a vaccine over the age of 55 to come forward.

Patients and members of the public attending the drop-in clinic must live in Norfolk and Waveney and within a 20-mile radius of the site they are attending.

Local symptom-free rapid-testing

Next week Alive St James Swimming Pool and Fairstead Community Centre will continue to offer lateral flow tests to all residents and workers in King's Lynn.

These quick tests can be taken whenever residents are out and will help break the chain of transmission of Covid-19. It's recommended that you take these tests if you are going out to work or even heading to the supermarket. It's quick to do and, even if you've had the vaccine, it's recommended that we all do it.

Workplace Testing Extension

Businesses, with more than 50 employees, have until the 31 March to apply for test kits for their staff – the registration page is available here: <https://www.gov.uk/get-workplace-coronavirus-tests>

The expansion of workplace testing will identify more positive cases of COVID-19 and ensure those infected isolate. This will reduce the spread of the virus and protect those who cannot work from home, and our vital services.

This programme is crucial given that around 1 in 3 people who are infected with COVID-19 have no symptoms so could be spreading the disease without knowing it. Broadening testing to identify those showing no symptoms will mean finding positive cases more quickly, and break chains of transmission.

This is particularly important to note for businesses such as non-essential retail and hospitality that are currently closed but which can reopen in steps 2 or 3 of the roadmap.

Grants for business

Since November last year over £19M has been paid in business support grants. This is in addition to nearly £40M paid during lockdown 1.

Applications for grants to 15 February 2021 close on 31 March 2021. Applications for grants from 16 February 2021 to 31 March 2021 will remain open until 31 May 2021.

These grants of up to £6,000 per premises for non-essential retail businesses, and up to £18,000 per premises for hospitality, accommodation, leisure, personal care and gym businesses will be payable from April 2021.

Exercise and recreation with your household or one other person in a public outdoor place. Household only indoors.



Wraparound care, including sport, for all children, to enable parents to work.



Stay at home. No domestic or international holidays.



Funerals (30 people). Weddings and Wakes (6 people).

29 March



Rule of 6 or two households outdoors. No household mixing indoors.



Outdoor sport and leisure facilities.



Organised outdoor sport (children and adults).



Minimise travel. No domestic or international holidays.
