22128 **Declarations of Interest**

22129 **Apologies for Absence**

Cllr H Whyman-Naveh was late for the meeting, joining at item 22132

22130 **Public Participation**

It was clarified that the amendment to a current planning application did not include changing the priority for vehicles coming out of the development.

22131 **Minutes of the Full Council meeting held on 11th October 2022**

The minutes were accepted and signed as an accurate record of the meeting.

22132 **Clerks report and progress on any matters arising from previous meetings**

22133 **Police Snap Meeting** – The clerk reported that she had attended and it had been agreed to add the open space in lodge walk as a priority area following a complaint from a resident about antisocial behaviour. It was noted that the speed camera van could be requested if a particular area was causing concern, priority for this was given to villages where there were active volunteer speed monitoring groups. Parking enforcement had been contacted and asked to attend in Snettisham to enforce the restrictions. Any particular incidents or patterns of infringement should be reported to BCKLWN.

22134 **Carrstone Crescent** – It was noted that the developer had respectfully declined to change the name, this had been accepted by BCKLWN and would go ahead as Carrstone Crescent.

22135 **UK Power Networks** – Cllr J Penty was thanked for spending time to complete the initial form. A first estimate of £6652 +vat with lead times of 7 to 14 weeks was noted. It was agreed to go to the next stage and set up a site visit and obtain a formal quote.

- 22142 **To agree a budget to purchase a projector**– a budget of £500 was agreed to purchase a projector
- 22143 **Highways Issues** – Cllrs noted the concerns of residents regarding a number of highways issues. The possibility of a working group to look at the issues was discussed. Cllrs agreed to defer making a decision and invite the concerned residents to a meeting to discuss this further
- 22144 **To Receive gifts from Anafarta** – Cllrs received the framed photograph and embroidered scarves. The intricate work around the edge of the scarves was particularly noted and admired. It was agreed to frame the gifts with a view to displaying them in the Memorial Hall, if permitted.
- 22145 **Arrangements for the 70th Anniversary of the flood.** – It was agreed that the Service could be held on 29th January, this would be covered by the Council insurance.
- 22146 **Planning – registering as an interested party to comment on the application to build and manage an energy from waste combined heat and power plant by Medworth CHP Ltd, in Wisbech** Cllrs expressed concern about pollution, the need for the facility and the effect on the infrastructure if waste was transported to the site. It was agreed to register as an interested party.
