4 Minutes

The minutes from the Amenities Committee Meeting held on 28th February 2023 were agreed and would be signed by the Chairman at the next meeting.

5 Report on the progress of items from previous meetings was received.

Coronation Event – The flyer had been printed off and was being delivered to homes by the events committee. It was also displayed on the notice board and website.

Anyone coming to the litter pick on Monday was to let the clerk know.

Streetlight St Mary's Close – UKpower network had given a date in June for reconnection, the clerk had asked for this to be expedited.

UK Power networks – thanks were recorded to Cllrs who had carried out some of the works. The electrician had ordered the cabinet and this would be fitted 26 th April.

Market Place puddles– Cllr Penty reported that he was waiting for quotes.

6. **Tree Report** – only one quote had been received, it was agreed to wait for further quotes before commissioning the work.

7. **To receive information regarding a composting toilet on the allotments** – Cllrs discussed having a composting toilet at the allotments. It was thought that this might become a requirement in the future and cost £8-9k. It was agreed to defer this to a future meeting, no timescale was identified.

8. **Traffic Group** – Cllr Whyman-Naveh updated Council on the priorities identified by the Traffic group, 20 is plenty – limiting the speed limit to 20 throughout the village, developing a speed watch group and identifying refuge areas on Alma Rd to help

ease congestion. It was agreed that these priorities be taken forward in discussion with NCC highways. It was also noted that the traffic group would also continue to look at parking and a crossing near the co-op.

10. Planning

- 10.1. **22/02204/F** Amendment fencing at 23 the Beach – Cllrs had previously objected to this application and were concerned that although the wind turbine had been removed the fencing would be too high, blocking light for the adjoining property.

- 11. Play area at the Memorial Field** – it was noted that Cllr J Penty had liaised with the school and would look to develop a scheme with contractors so that grant funding could be sought.
